WHAT IS "HARM REDUCTION"?

It is staying safe and healthy while using substances.

[Harm reduction programs connect people who use drugs to supplies (e.g., new syringes, fentanyl test strips, and naloxone) that help prevent overdose deaths and the spread of infections. They also connect people to healthcare, medication for opioid use disorder (MOUD), HIV and Hepatitis C testing, and a community space free from judgment and stigma.]

Where to find Naloxone In Mercer County:

1. Hyacinth Foundation, Trenton

The Hyacinth Foundation is one of several New Jersey Harm Reduction Centers serving the Trenton Area. Hyacinth is a safe, trauma-informed, non-stigmatizing space for people who use drugs to access sterile syringes, needles, injection equipment, and the life-saving drug naloxone (also known as Narcan), along with education on safer use, overdose prevention, and safe disposal of used equipment. Hyacinth is also an HIV service provider.

3. Mercer County Library System

"In partnership with the New Jersey Department of Human Services, MCLS is participating in New Jersey's Naloxone Distribution Program – designed to ensure communities across Mercer County impacted by the opioid epidemic have low-barrier access to Naloxone (Narcan). Each of the nine MCLS branches has kits available for distribution. No prescription is needed to access Narcan from the MCLS branches. 4. New Jersey Coordinator for Addiction Responses and Recovery Strategies:

"All New Jersey pharmacies dispense naloxone without an individualized prescription pursuant to a standing order from the Deputy Commissioner, Public Health Services for the NJ Department of Health. Individuals may also obtain a prescription for naloxone from a physician, physician assistant, or advanced practice nurse, and have it filled at a local pharmacy, even if the person is not the intended user but a third-party individual (friend, family member, caregiver, etc.) who may assist someone in an opioid overdose emergency."

"Medication-assisted treatment (MAT) is the use of medications, in combination with counseling and behavioral therapies, to provide a 'whole-patient' approach to the treatment of substance use disorders. Buprenorphine, methadone and naltrexone are used to treat opioid use disorders to short-acting opioids such as heroin, morphine, and codeine, as well as semi-synthetic opioids like oxycodone and hydrocodone. These MAT medications are safe to use for months, years, or even a lifetime" - Substance Abuse and Mental Health Services Administration (SAMHSA)
